**MARKET EXHIBITOR RULES & INFO**

- Exhibitors must reside in the State of Florida.
- All products You sell must be handmade or homegrown by You. Components can come from other sources but the finished items must be your unique creation. This is not a flea market event selling used goods but rather a showcase of local talent & creativity.
- Any food or drink products for sale cannot conflict with those being sold by the official food & drink vendors selected by OCHS (& located in a separate designated area) and any such products must be pre-approved by Us.
- A description of each type of item You plan to sell must be submitted on/or attached to the form provided. All items for sale are subject to Market Sponsor approval prior to the event. The Market Sponsor reserves the right to not permit the sale of any product at its discretion. No alcoholic beverages may be present, consumed, or sold at this event.
- Electrical access will cost extra. Other than the costs to exhibit as detailed herein, You will collect and earn 100% of any approved product that You sell at the Market. You are responsible for any taxes required by law.
- You are responsible for your own cash drawer, change, security, & liability coverage and must complete & return the attached Release of Liability and Indemnity Agreement to Us by the specified deadline.
- Please be prepared to protect your products & space in any type of weather - rain or shine. Any tent larger than 10'x14' requires a special permit in advance at an additional cost.
- On Sat., Nov. 11, vendor set-up begins at 7:00 a.m. and ends at 9:00 a.m. and takedown begins at 4:00 p.m. & ends at 6:00 p.m. No vehicles will be allowed in the Village or Market area on the event day between the hours of 9:00 a.m. & 4:00 p.m.
- The vendor space and table rental fees are non-refundable.

# RELEASE OF LIABILITY AND INDEMNITY
