admission: \$7 adults, \$3 children under 12)

## Market Vendor Rules

- Allocated spaces are 12'x12'. Vendors needing additional room must reserve two spaces. No vendor may reserve more than two spaces.
- No electric is available and vendors must provide their own tables/tents/chairs, etc. Tents should be no larger than 10'x10'.
- Vendors may have one item appraised at no charge. Two additional items may be appraised at \$15 per item. Payment for additional items must be made when paying vendor fee.
- Items being sold must be vintage or antique in adherence to the theme of the event. Vendors may bring in personal snacks and beverages, but they may not be sold or shared.
- Food vendors are responsible for acquiring appropriate license to prepare and/or sell food.
- No alcohol, weapons or living creatures may be sold.
- A description of the items you are selling must be included on the application form. OCHS reserves the right to limit or refuse the sale of any items.
- Vendors may keep all proceeds earned and are responsible for their own taxes.
- Vendors must have their own liability coverage and return the release of Liability & Indemnity form to OCHS prior to the start of the event.
- Vendor set-up is from 7-9 a.m. on May 18. Take down begins at 1 p.m. and must be completed by 3 p.m. No vehicles are permitted into the village between the hours of 9 a.m. and 1 p.m.
- Event will be held rain or shine. Be prepared. No Refunds.
